## What is this product?

### Type

This product is a share of a compartment (the "Sub-Fund") of an investment company authorised as an Undertaking for Collective Investment in Transferable Securities (UCITS) under Luxembourg law (the "Fund") in the form of a Société d'Investissement à Capital Variable (S.I.C.A.V).

### Term

The Fund has no maturity date. Notwithstanding this provision, the Fund may be dissolved at any time by a resolution taken by the general meeting of shareholders.

### Objectives

The Sub-Fund invests primarily in Eurozone sovereign and corporate investment grade bonds and treasury certificates seeking to optimize yield while preserving capital security, asset stability and high liquidity. Up to 50% may be invested in non-Euro currencies. The fund may hold cash accessory. The fund is actively managed without reference to a benchmark. The underlying investments do not take into account the EU criteria for environmentally sustainable activities.

### Intended investor

The Sub-Fund is suitable for an investor wishing to participate in the performance of the stock markets through equity-type investments. As stock market fluctuations may lead to capital losses, investors should be able to accept losses with a medium- to long-term investment horizon and have experience of volatile products and financial markets.

*Depository:* Banque Degroof Petercam Luxembourg S.A

*Dividend income:* This class is a capitalisation class meaning that income is reinvested.

*Conversion right:* The investor may have the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

## What are the risks and what could I get in return?

### Risk Indicator



The Recommended Holding Period of the product is 3 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Fund is not able to pay you. We have classified this Fund as 3 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact the Fund's capacity to pay you. You may lose up to the totality of the amount you have invested in the Fund. **Be aware of currency risk. ## Performance Scenarios

Payment within 3 business days. There is no required minimum holding period, but sale within a short period may incur capital gains tax.
